Purpose. The 5-Year and Annual PHA Plans provide a ready source for interested parties to locate basic PHA policies, rules, and requirements concerning the PHA’s operations, programs, and services, including changes to these policies, and informs HUD, families served by the PHA, and members of the public of the PHA’s mission, goals and objectives for serving the needs of low- income, very low- income, and extremely low- income families

Applicability. The Form HUD-50075-SM is to be completed annually by **Small PHAs**. PHAs that meet the definition of a Standard PHA, Troubled PHA, High Performer PHA, HCV-Only PHA, or Qualified PHA do not need to submit this form.

Definitions.

- (1) **High-Performer PHA** – A PHA that owns or manages more than 550 combined public housing units and housing choice vouchers and was designated as a high performer on both the most recent Public Housing Assessment System (PHAS) and Section Eight Management Assessment Program (SEMAP) assessments.
- (2) **Small PHA** - A PHA that is not designated as PHAS or SEMAP troubled, and that owns or manages less than 250 public housing units and any number of vouchers where the total combined units exceed 550.
- (3) **Housing Choice Voucher (HCV) Only PHA** - A PHA that administers more than 550 HCVs, was not designated as troubled in its most recent SEMAP assessment and does not own or manage public housing.
- (4) **Standard PHA** - A PHA that owns or manages 250 or more public housing units and any number of vouchers where the total combined units exceed 550, and that was designated as a standard performer in the most recent PHAS or SEMAP assessments.
- (5) **Troubled PHA** - A PHA that achieves an overall PHAS or SEMAP score of less than 60 percent.
- (6) **Qualified PHA** - A PHA with 550 or fewer public housing dwelling units and/or housing choice vouchers combined and is not PHAS or SEMAP troubled.

Conversion of Public Housing to Project-Based Rental Assistance or Project-Based Vouchers under RAD

The Western Regional Housing Authority (WRHA) will continue to evaluate and research the feasibility of converting its Low-Rent Public Housing (LRPH) apartment complexes to either Project-Based Rental Assistance (PBRA) or Project-Based Vouchers (PBV) through the Rental Assistance Demonstration (RAD) program. This conversion is being explored as a long-term strategy to preserve affordable housing units while addressing significant capital improvement needs that exceed currently available Public Housing funding. Many of WRHA's public housing properties require substantial rehabilitation and modernization due to aging infrastructure and deferred maintenance. Current Public Housing capital and operating funds are limited and are not sufficient to fully address the long-term physical needs of the properties. By converting units through RAD, WRHA would transition these developments from the traditional Public Housing program to the Section 8 platform, which provides a more stable and predictable source of annual funding through long-term Housing Assistance Payment (HAP) contracts. Participation in the RAD program would allow WRHA to leverage additional financial resources from external funding sources such as private lending, tax credit equity, and other federal, state, or local funding opportunities. These financing options can be combined with Section 8 rental assistance to support comprehensive rehabilitation, modernization, or redevelopment of the existing properties. The ability to access these funding streams will significantly enhance WRHA's capacity to address critical building improvements, extend the useful life of the housing stock, and ensure long-term sustainability of the units. WRHA will continue to assess the financial feasibility and physical needs of each property while working to maintain and operate the housing developments with currently available funding. However, the Authority recognizes that larger capital investments will ultimately be necessary to preserve the properties and maintain safe, decent, and sanitary housing conditions for residents. Through the RAD conversion process, WRHA may be able to address current operational and capital challenges by facilitating moderate rehabilitation, substantial rehabilitation, or potential new construction where appropriate. Converting the properties to Section 8 assistance under PBRA or PBV would help stabilize funding, preserve affordable housing units in the community, and position WRHA to make long-term improvements that benefit current and future residents.

Units With Approved Vacancies for Modernization: As the Western Regional Housing Authority (WRHA) continues to rehabilitate and modernize its housing units, it may be necessary to temporarily remove certain units from the active Public Housing unit count while rehabilitation work is being completed. When units require significant repairs, modernization, or upgrades that make them unsuitable for occupancy during construction, WRHA will request approval from the U.S. Department of Housing and Urban Development (HUD) to classify these units as approved vacancies for modernization. This process allows WRHA to take units offline for the duration of the rehabilitation work without negatively impacting occupancy requirements or performance measurements. Removing units from the Public Housing inventory on a temporary basis ensures that the Authority remains in compliance with HUD reporting and occupancy standards while construction activities are underway. Approved vacancies for modernization provide WRHA the flexibility to perform necessary capital improvements, including structural repairs, system replacements, accessibility upgrades, energy efficiency improvements, and other modernization efforts that improve the safety, functionality, and long-term viability of the housing units. Once rehabilitation work is completed and the units meet HUD housing quality and safety standards, WRHA will place the units back into service and make them available for occupancy. Through this process, WRHA aims to maintain the overall quality of its housing stock while ensuring that modernization efforts are conducted in an organized and compliant manner that supports the long term preservation of affordable housing within the Authority's portfolio.

B.3 Progress Report.

- Western Regional Housing Authority (WRHA) is using CFP funds to implement a series of targeted improvements across its housing communities to enhance safety, accessibility, and resident comfort. At Valley Vista, projects include the replacement of all unit windows to improve energy efficiency and security, comprehensive sidewalk repairs to address cracks and uneven surfaces, and expansion of driveways to accommodate increased parking needs. At Hillside, all trees that are in contact with residential units or electrical wires will be carefully pruned to prevent potential hazards, and sidewalks will be repaired and leveled to eliminate tripping risks. At Pyramid Village, roof-mounted AC units that were damaged during a severe dust storm will be replaced to restore proper climate control, and sidewalks throughout the community will be repaired to remove all tripping hazards. These projects reflect WRHA's ongoing commitment to maintaining safe, accessible, and well-maintained housing while addressing both immediate repair needs and long-term infrastructure improvements.
- Western Regional Housing Authority (WRHA) has consistently achieved the highest occupancy levels in its Section 8 Voucher Program, ensuring full utilization of its authorized budget authority. The agency has revised and streamlined policies and procedures to improve operational efficiency, enhance transparency, and clarify program requirements for staff and participants. WRHA closely monitors program utilization to ensure that funds are promptly allocated to applicants on the waiting list as they become available. Current tenants wishing to transfer their Voucher to another housing agency ("portability") are permitted only to lower-cost areas unless the Housing Authority provides written approval to absorb the Voucher, ensuring fiscal responsibility. To maintain and improve lease-up rates, WRHA has established and periodically adjusted Payment Standards, enabling families to successfully lease units within the jurisdiction and increasing opportunities for mobility within the community. Staff continually monitor compliance with the Rent Reasonableness Analysis process to ensure fair and appropriate rent determinations, with quarterly reviews conducted at a minimum. These efforts reflect WRHA's ongoing commitment to maximizing program effectiveness, promoting housing stability, and supporting resident choice and mobility.
- WRHA is committed to providing accessible, responsive, and resident-focused customer service. The agency emphasizes open communication and an "open-door" approach, ensuring that residents, applicants, and program participants feel comfortable engaging with staff. This commitment fosters trust, encourages collaboration, and supports the effective operation of the agency while enhancing overall service quality.
- WRHA strictly adheres to affirmative action and Fair Housing policies, ensuring that admissions and occupancy in all programs are conducted without regard to race, color, religion, national origin, sex, familial status, disability, sexual orientation, or gender identity. Section 8 counseling emphasizes locating units outside areas of concentrated poverty or minority populations, and the agency actively encourages landlords in those areas to participate in the program to broaden housing opportunities. WRHA provides regular Fair Housing training for supervisors and staff and ensures that Section 8 and LRP participants receive the most current information on Fair Housing and equal opportunity during their briefings. These efforts support equitable access, expand housing choices, and promote compliance with all applicable civil rights requirements.

A PHA will be considered in compliance with the certification requirement to affirmatively further fair housing if the PHA fulfills the requirements of §§ 903.7(o)(1) and 903.15(d) and: (i) examines its programs or proposed programs; (ii) identifies any fair housing issues and contributing factors within those programs, in accordance with 24 CFR 5.154; or 24 CFR 5.160(a)(3) as applicable (iii) specifies actions and strategies designed to address contributing factors, related fair housing issues, and goals in the applicable Assessment of Fair Housing consistent with 24 CFR 5.154 in a reasonable manner in view of the resources available; (iv) works with jurisdictions to implement any of the jurisdiction's initiatives to affirmatively further fair housing that require the PHA's involvement; (v) operates programs in a manner consistent with any applicable consolidated plan under 24 CFR part 91, and with any order or agreement, to comply with the authorities specified in paragraph (o)(1) of this section; (vi) complies with any contribution or consultation requirement with respect to any applicable AFH, in accordance with 24 CFR 5.150 through 5.180; (vii) maintains records reflecting these analyses, actions, and the results of these actions; and (viii) takes steps acceptable to HUD to remedy known fair housing or civil rights violations. impediments to fair housing choice within those programs; addresses those impediments in a reasonable fashion in view of the resources available; works with the local jurisdiction to implement any of the jurisdiction's initiatives to affirmatively further fair housing; and assures that the annual plan is consistent with any applicable Consolidated Plan for its jurisdiction. (24 CFR §903.7(o)).
